

## **Slate of Candidates Filed NSDCAR 2008 Election**

Here it is! Your chance to impact the direction of **your** association by electing those REALTORS® who will represent you on the Board of Directors in 2009. The election will take place the two week period of June 13 through June 27. There will be no paper ballots this year. **Electronic Ballots will be sent to each eligible voter by direct e-mail on Friday June 13** along with simple instructions on how to cast your vote. Please make sure that we have your current e-mail address or you will not receive your ballot. You will also be able to access your ballot by going to our website at [www.nsdcar.com](http://www.nsdcar.com) and look for the VOTE NOW button. You must vote your **electronic ballot no later than 5:00 p.m. on Friday, June 27**. At that time, the system will shut down and no further votes will be accepted or recorded. Votes will be tallied electronically, and results will be posted on the website on June 30.

**The following is the slate filed by the NSDCAR Nominating Committee.**

All members will vote on the President-Elect officer candidates. **Kurt Kinsey, Blue Pacific REALTORS® in Oceanside** will automatically become the Association President for 2009 by virtue of having been elected President-Elect in last year's election. Similarly, the individual you elect to be 2009 President-Elect in this election may automatically become President of NSDCAR in 2010, subject to the results of a proposed Bylaw amendment vote.

All members will also vote for a Director-at-Large. The Director-at-Large may come from any District of NSDCAR and does not represent any specific District, but rather the NSDCAR membership as a whole.

For those of you whose offices are located in even numbered Districts (Carlsbad, Vista/San Marcos, Fallbrook/Bonsall), you will vote on candidates for your **District Director on the Board representing your respective district**. Those elected will take office January 1, 2009 for terms ending December 31, 2010. Directors from other districts (Carmel Valley, Encinitas, Oceanside, Escondido, Valley Center) are not up for election until next year, so you will not have a Director candidate on your ballot.

At time of this printing, we are waiting for final Bylaw amendment proposal verbiage for the ballot. When ready, this will be posted in Quick Facts and on the website at [www.nsdcar.com](http://www.nsdcar.com).
